**RESOLUTION :-**

The pay-scales of Deputy Engineers and Assistant Engineers Class-II have been revised vide Government Resolution No. PAS 1071/8226- E (2) Section – I, dated the 19<sup>th</sup> July, 1971.



There are also a few typographical errors in some of the rules. It has been decided to slightly amend some of the rules in the Government Resolution, dated the 19<sup>th</sup> December, 1970.

**ANNEXURE 'A'**

Rules 5, 9, 12(a), 14, 15, 16 (b), 19, 21, 25, 32, 34 and 39(b) of Government Resolution No. GAB 1070-E (1), dated the 19<sup>th</sup> December, 1970 should be constituted by the following rules.

**RULES – 5 :**

The Maharashtra Service of Engineers shall consist of Class-I and Class-II and will comprise the following cadres with the scales shown against them separately under the Irrigation and Power Department and the Buildings and Communications Department.

<b><u>Class-I</u></b>	<b><u>Pay-Scales</u></b>
1. Chief Engineers.	1800-100-2000-150/2 -2300 (w.e.f. 1 <sup>st</sup> April, 1971)
2. Superintending Engineers	1300-60-1600
3. Executive Engineers	650-(6 <sup>th</sup> year)-45-1100-50-1200
4. Assistant Engineers Class-I.	410-30-650-EB-45-1010 (Fixed pay of Rs.380/- during the period of probation.)

<b><u>Class-II</u></b>	
1. Deputy Engineers.	325-25-400-30-510-EB-30-730-35-940
2. Assistant Engineers, Class-II	325-25-400-30-610-EB-30-730-35-940 (Fixed pay of Rs. 325/- during the period of probation).
3. Sub Divisional Engineer.	325-25-550-30-610-EB-30-910
4. Sub Divisional Officers	325-25-550-30-610-EB-30-880

**RULE – 9 :**

To be eligible for admission to the examination, a candidate must :-

- (i) have attained the age of 21 years and not have attained the age of 25 years (30 years in the case of candidates belonging to Backward Classes) on the date as may be prescribed by the Commission, and

- (ii) have passed the B.E. (Civil) degree examination of a statutory University of possess a qualification recognised by the Government of Maharashtra as equivalent to such a degree.

Any person appointed to the posts of Assistant Engineer Class-I or Assistant Engineer Class-II in the Maharashtra Service of Engineers Class-I or Class-II on or after the 1<sup>st</sup> November, 1965 shall, if so required, be eligible to serve in any defence Service or post connected with the Defence of India, anywhere in India or abroad, for a period of not less than four years including the period spent on training, if any, on such conditions as are determined by the Government of India.

Provided that such persons –

- a) shall not be required to serve as aforesaid after the expiry of ten years from the date of his appointment.
- b) Shall not ordinarily be required to serve as aforesaid after attaining the age of forty years.

**RULE 12 (a) :-**

The cadre of Deputy Engineers will consist of –

- i) all officers confirmed upto the date of commencement of these rules as Deputy Engineers, whether actually working in or only having a lien on the posts.
- ii) all direct recruits who have been appointed upto the date of commencement of these rules on probation against permanent posts of Deputy Engineers,
- iii) all officers who were officiating as Deputy Engineers on 30<sup>th</sup> April, 1960 provided their promotions prior to 30<sup>th</sup> April, 1960 are not deemed to be fortuitous, and
- iv) those who were not promoted prior to 30<sup>th</sup> April 1960 but who have been included in the Select Lists for the period prior to 30<sup>th</sup> April 1960 of Overseers fit to be Deputy Engineer.

**RULE 13(a) :**

Officers who, on the date of commencement of these rules, are officiating in the erstwhile cadre of Deputy Engineers from a date later than 30<sup>th</sup> April, 1960 and those who were promoted earlier than 30<sup>th</sup> April, 1960 but whose promotions are deemed to be fortuitous, but excluding these referred to in Rule 12 (a) (iv) shall be treated as appointed from the date of commencement of these rules to officiate :-

- (i) as Sub-Divisional Engineers if they are graduates and
- (ii) as Sub-Divisional officers if they are not graduates.

**RULE 14 :**

- (a) Subject to Rules 13,15 and 17, members of the District Technical Service Class-III (Engineering) under the Zilla Parishad will be eligible for appointment by selection to the cadre of officiating Sub-Divisional Engineers or Sub-Divisional Officers, as the case may be, provided that their appointments shall be restricted to 9 temporary post of Sub-Divisional Engineers and 9 temporary posts of Sub-Divisional officers under Irrigation and Power Department and 35 temporary posts of Sub-Divisional Engineers and 34 temporary posts of Sub-Divisional officers under the Buildings and Communications Department, which should be reserved for them in these cadres.
- (b) The number of posts reserved for Zilla Parishad Employees should be reviewed every two years.
- (c) In case qualified Zilla Parishad employees are not available, the vacancies out of the reserved posts may be temporarily filled by qualified Junior Engineers or Overseers, as the case may be from the Department concerned until qualified persons from the Zilla Parishads are available for appointment by selection.

**RULE 15 :**

To be eligible for promotion/appointment by selection as officiating Sub-Divisional Engineer, a Junior Engineer in the Subordinate Service of Engineers or a graduate in the District Technical Service Class III (Engineering) under the Zilla Parishad should have a minimum service of three years.

**RULE 16 (B) :**

Appointments from District Technical Service, Class III (Engineering) under the Zilla Parishads shall be similarly made by selection from the State-wise Seniority list of graduates maintained by the Rural Development Department.

**RULE 19 :**

The appointments to the cadre of Sub-Divisional Officers from the District Technical Service Class III (Engineering) under the Zilla Parishads shall also be made by selection from the State-wise seniority lists maintained by the Rural Development Department.

**RULE 21 :**

From 1<sup>st</sup> April 1974 onwards, the promotion/appointment as Sub-Divisional Engineer or a Sub-Divisional Officers shall be further subject to passing the professional Examination of overseers unless an exemption or extension of time for passing the examination is granted in any particular case.

**RULE 25 :**

After all the Deputy Engineers (excepting those who are finally considered unfit for promotion) have been promoted, the 60% posts of Executive Engineers available for promotees from Class II shall be filled by promotion in the following proportions :-

- i) 25% by promotion from among the direct recruits to Class II;
- ii) 25% by promotion from among the graduate promotees in Class-II; and
- iii) 10% by promotion from among the non-graduate promotees in Class-II.

**RULE 32 :**

Assistant Engineers, Class I, appointed before the commencement of these rules will be confirmed as Executive Engineers from a date not later than the date on which they completed a total service of nine years unless this period is extended on grounds of unsatisfactory work.

**RULE 34 :**

On appointment as Sub-Divisional Engineers / Sub-Divisional Officers from the District Technical Service (Class III) – Engineering, their seniority shall be fixed vis-à-vis those in the Irrigation and Power Department / Buildings and Communication Department with reference to the dates of appointment / promotion.

**RULE 37 (B) :**

In the list of permanent Deputy Engineers, the names of officers confirmed in a particular year shall be arranged in the following orders –

- i) Direct Recruits to Class II in a bunch,
- ii) Promotees from Class III in a bunch,
