Module No.	Module Name	Module covers
M11	Inspection & Quality Control	The processes related to inspection of works and quality control activity.
	Maintenance	
M12	Dam Safety / Monitoring	The activities that need to be undertaken for ensuring safety of dam and include activities viz DSO inspections, Gate inspection, Preparation of annual health report, annual instrumentation data report and taking actions for the compliance of instructions issued by inspecting authority.
M13	Maintenance of Irrigation Projects	This module refers to the preparation of annual maintenance plan for irrigation projects and its approval by competent authority
M14	Land Reclamation	This module will include monitoring activities to avoid land damages due to irrigation & identifying need to undertake drainage scheme & monitoring the effectiveness of drainage schemes undertaken.
M15	Flood Control & Disaster Management	Activities like preparing EPA, appointment of nodal officers, collection of rain fall, rain gauge and reservoir release data, flood foreacasting, issuing operational instructions, dissemination of flood data to all concerned. It also covers activities related to compliation of flood data and preparing basin wise flod report.
	Irrigation Management	
M16	Delineation of Command and WUA	Activities stipulated in MMISF Act 2005 regarding delineation of comand of irrigation project up to minor level that will be managed by WUA, formation of WUAs, its elections and agreements to be made with WUAs. It also covers monitoring of canal maintenance works to be undertaken before handling over of the scheme to WUA & actual handling over.
M17	Water Entitlement	Activities regarding wter entitlement covering its all aspects viz issuance, review, monitoring of use, transfer and adjustment during distress.
M18	Water Release Schedules	Activities related to preparation of PIP, collection of water demand, scrutiny of water applications, issue of water passes,, preparation of rotation program and communicating the same to all concerned.
M19	Assessment, Billing and Recovery	Activities related to water/crop measurements, assessment, billing, recovery, maintaining financial accounts of water users and monitoring recovery.
M20	Water Auditing and Benchmarking	Activities regarding collection of reseroir wise daily water utillization data & water account preparation, water auditing and bench marking with respect to preset indicators and standards including publishing these reports.

- UAT of all 34 modules completed at KDC.
- User Acceptance Testing (UAT-II) of modules will commence from April 2012.
